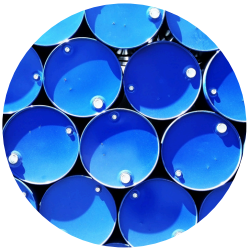

We need high resolution images so that we can promote your trailblazing in the best light in our awards publication. Don't forget to also include a copy of your company logo.

At the end, please give us permission to use and promote your great work through our network and publications. The point of sharing is that we can learn together and make cargo handling and coordination ever more safe.

Am I eligible to enter?

Entry to the TT Club Innovation in Safety Award is open to anyone involved in Cargo Logistics - members, non-members, individuals, teams and companies.

How much does it cost to enter?

It is free to enter.

Are there any other important things to remember?

- All entries must be submitted in English.
- Any part of your entry may be used in our publicity material so please remove any commercially sensitive information that you do not want available in the public realm.
- Entries must be no longer than 1,250 words entries above this word limit may be disqualified.
- Consider including testimonials within your word limit.

Do you have an example entry?

NEED TO KNOW MORE?

Can I submit more than one entry?

Yes. If you choose to submit multiple entries, they must be distinct; addressing different solutions to the same health and safety challenge, or solutions to different challenges.

What is included in health and safety?

Your innovation can be in physical safety, health (short and long term illness prevention), mental health protection, skills and competence. It can be about health and safety culture including workforce engagement. It can be leading edge technology, simple practical physical solutions or anything in between. It can be people or technology focussed. We know that there are smart, committed people all across our industry who are doing great work. We are excited to see and champion your brilliant ideas!



What kinds of entries have we received in previous years?

We have seen submissions on anti-piracy; bulk operations; collision detection and prevention; container lashing, securing, refrigeration, stacking, technical characteristics and weighing. Dangerous goods, electricity, ladders, personnel safety, lifting, mooring and working at height have also provided exciting entries.



What is the judging process?

Winners and finalists are selected by a judging panel. The judging panel is comprised of independent experts from the Cargo Logistics industry. All entries will be reviewed by all the judges on the panel and scored using a standard scoring template. This ensures a measured and educated response to each submission.



What happens after I enter?

You will receive an email to confirm that your entry has been submitted correctly. If you do not receive this, please contact: secretariat@ichca.com

The shortlisted and winning entries are kept strictly confidential until they have been informed. You will be notified of your success privately to allow you time to prepare any reaction, announcement etc.

Shortlisted entries will receive a marketing pack containing digital marketing elements to add to their website, social media and emails. They will also be announced via email, displayed on our website and promoted through our communication channels.
